### Booth locations

Vendor booth slots are available inside and outside of the auction tent. Booths are subject to change by auction staff.

### Booth size

The standard booth is 10' x 10'. Pricing for 10' x 30' spaces includes

### Food

No food products may be offered or sold by vendors unless approved by Silver Auctions Arizona. If approved by SAA see Permits section.

### Electricity

Power is available for \$75 for each 15 amp circuit.

### Permits

All tax, permits, licensing, collection and remittance are the vendor's responsibility.

All local laws, taxation and business requirements must be adhered to.

Each vendor must have a valid Arizona tax permit in hand, including any required licensing from the city of Peoria.

### Sales Tax

Vendor is responsible to collect and pay sales tax to the State of Arizona and the city of Peoria.

### Passes

Each booth, no matter what size will receive 2 all auction vendor passes.

Auction admission (**vendors receive two free passes**)

Standard admission price is \$15 per day

### Load In

See schedule provided. No vehicles will be allowed in the auction tent at any time.

### Load Out

See schedule provided. No vehicles will be allowed in the auction tent at any time.

### Lost or Stolen Items

Silver Auctions Arizona provides security and will exercise reasonable precaution for protection of vendor property, but assumes no responsibility for loss or damage incurred during rental period.

### Damage to Property & Insurance
